## EASTERN STATES ARCHEOLOGICAL FEDERATION (ESAF) EXECUTIVE BOARD MEETING MINUTES

The 87<sup>th</sup> annual Executive Board meeting was held via ZOOM on Monday the 26<sup>th</sup> of October 2020.

President John Nass called the meeting to order at 6:36 PM. A rollcall determined that we had quorum present and we moved on to ESAF business.

**Officers present:** President John Nass, President Elect Jonathan Lothrop, Treasurer Timothy Abel, Corresponding Secretary Martha Otto, Recording Secretary Richard Doyle, Business Manager Amanda Valko, AENA Editor Arthur Spiess, Bulletin Editor Zachary Singer, and Webmaster Reporter Timothy Abel.

**State Society Representatives Present:** Faye Stocum for Delaware, Stephen Israel for Maryland, Alan Smith for Massachusetts, Dick Boisvert for New Hampshire, Dave Mudge for New Jersey, Timothy Abel for New York, Martha Potter Otto for Ohio, Amanda Valko for Pennsylvania, and David Fuerst for West Virginia.

**State Society Representatives Absent:** Ernest Wiegand for Connecticut, and Arthur Anderson for Maine, Dean Knight for Ontario.

### **New Business**

**2021 Annual Meeting:** President John Nass addressed the 2021 Ohio meeting as the first order of business and introduced Kevin Nolan and Bob Genheimer of the Ohio Archaeological Council the hosts of the 2021 meeting. The ACO had a meeting last week and concerns were raised regarding the ongoing Covid-19 pandemic and if an in-person meeting could take place safely. Also, the ACO signed a contract with the hotel and put a deposit of \$1,200 down. It was noted that the hotel's cancellation stipulations in the contract get quite onerous financially the closer we get to the meeting and in order to get the entire deposit back we would need to decide by the 3<sup>rd</sup> of November, eight days away, if we wanted to proceed with the meeting. Genheimer also indicated that they could also host a virtual meeting in 2021 instead. After much discussion Curtiss Hoffman moved that ESAF cancel the 2021 in-person meeting, Richard Doyle seconded the motion and it passed unanimously.

There was additional discussion regarding whether to have the virtual meeting with Ohio in 2021 or have an in-person meeting with them in 2022. Genheimer indicated that they could do one or the other but not both. After further discussion Arthur Spiess moved that we table this discussion and let Jonathan Lothrop, John Nass, Martha Potter Otto, and Genheimer decide how we would proceed in 2021 and 2022. Dave Mudge seconded the motion and it passed unanimously.

**Recording Secretary's Minutes:** Arthur Spiess moved that we accept the minutes as circulated via email. Al Smith seconded the motion and it passed unanimously.

**Corresponding Secretary's Report:** Martha Potter Otto reported that she would hold off until the end of November to complete the state society's directory due to elections that occur in November. Otto indicated that she has looked into having Vermont rejoin ESAF and she noted that Vermont has changed to a non-dues paying organization. Her efforts are ongoing. She further noted that the Virginia society has not appointed an ESAF Representative to replace Jack Hranicky. David Fuerst indicated that he would contact Elizabeth Moore or Forest Morgan to find out about a replacement and their continued involvement. Also, it was noted that the Association of Professional Archaeologists of New Brunswick has joined and Otto will contact them for the Directory details. Faye Stocum moved to accept the report as presented, Al Smith seconded the motion and it passed unanimously.

**Treasure's Report:** Timothy Abel reported that we finished last year with a bank balance of \$53,693.85. The expenses so far this year total \$16,490.51 and income totals \$1,287.84 but does not reflect the Business Offices income. This represents a loss of \$15,202.67 Abel noted that he had moved \$10,000 from the Wells Fargo Account to the checking account making for a Balance total of \$43,850.35. Arthur Spiess moved that we accept the Treasure's report as presented. Curtiss Hoffman seconded the motion and it passed unanimously.

**Editor's report:** Arthur Spiess reported that the 2020 issue of AENA was printed and in the Business Manager's hands by mid-September. It was a little more expensive this year as it was longer than usual. We have several articles on hand for the 2021 issue and it's looking like there will be no problems in filling the next AENA. Spiess noted that we had income from JSTOR of approximately \$4,400 up a couple hundred dollars more than last year. Al Smith moved that we accept the editors report as presented, Faye Stocum seconded the motion and it passed unanimously.

**Bulletin Editor's Report:** Zac Singer reported that he needs the full abstracts and that only Maryland and Massachusetts had sent the Affiliated Societies reports so those portions of the bulletin still needs to be completed. There was some discussion regarding how to get the reports from the various state reps. Singer also noted that he was using the format used by Roger Muller. Dave Mudge moved that we accept the report and Al Smith seconded the motion, it passed unanimously.

**Business Manager's Report:** Amanda Valko reported that she had a preliminary report as there are still a few loose ends in working with QuickBooks. There's \$796.85 in the Huntington checking account and \$88.17 in the Huntington savings account for a total of \$1,175.58. The latest issue of AENA was delivered in September. Mailing envelopes have been stuffed and are awaiting labels. Volume 48 will be in the mail at the end of October or the beginning of November. Included in the mailing is a cover letter, a 2021 membership form, and an order form for past issues of AENA. Also posted on the website are the covers and table of contents for volume 48 and the previous three years as well. A total of 11 back issues were ordered and sent out this year. Memberships from year to year seems quite steady at just over 300 individuals and institutions. Faye Stocum moved to accept the Report as presented, Al Smith seconded the motion and it passed unanimously.

**Louis Brennan and Ronald A. Thomas Awards:** Arthur Spiess reported that there were no Brennan Award applications for 2020. There was one application for the Ronald A. Thomas award for \$1,000 from David Leslie of Archaeological and Historical Services, Inc. The proposal is to prepare the "Edgewood Apartments Development Project, Plainview, Massachusetts" data recovery report by Brian Jones and David Leslie for publication as an AENA article. The significant information focuses on an Early Archaic (Gulf of Maine Archaic) component, with radiocarbon dates. The Thomas Award Committee consisted of Jon Lothrop, Richard Doyle, and Arthur Spiess. We unanimously found the writing, information, and graphics to be worthy of a Thomas Award. The Ronald A. Thomas Award Committee recommends a grant of \$1,000 to Archaeological and Historic Services, Inc., Storrs, CT, to edit the Edgewood Apartment project for AENA publication. Faye Stocum moved that we accept the report and recommendation as presented, Amanda Valko seconded the motion and it passed with one abstention, Zac Singer is a co-author on this paper.

**Nomination Committee Report:** Kurt Carr reported that the committee consisting of himself, Rebecca White, Stephen Israel, and Dean Knight quickly came to the decision of choosing Zac Singer for the next President Elect. It was noted that Singer had accepted. President Nass then asked if the other elected officers would continue in their current capacities and they all responded affirmatively. The slate of officers to go before the membership is as follows; President Jon Lothrop, President Elect Zac Singer, Corresponding Secretary Martha Potter Otto, Recording Secretary Richard Doyle, Treasurer Timothy Abel, Business Manager Amanda Valko, AENA Editor Arthur Spiess, and Webmaster reporter Timothy Abel. Faye Stocum moved to accept the slate of officers as recommended, Al Smith seconded the motion and it passed with one abstention, Zac Singer.

There was additional discussion regarding the election of officers by the membership. Since we will not be having a membership meeting this year it was decided that we would have to get the election paperwork out to the membership. Amanda Valko indicated that she had emails for most of the members and could include the remainder with the AENA Mailing if someone got the insert paperwork to her. Spiess moved that we proceed with the mailing of AENA and do a combined email and snail mail, for those without email addresses, to the membership dealing with the election of the slate of officers. Responses need to be returned by the end of the year. Curtiss Hoffman seconded the motion and it passed unanimously. President John Nass indicated that he would work with Amanda and Jon Lothrop to get the proper paperwork out to the membership.

**Membership Committee:** Janet Johnson presented her report and requested additional members. Amanda Valko agreed to be on the committee too. Al Smith moved to accept the report as presented and circulated. Dave Mudge seconded the motion and it passed unanimously.

**Education Committee:** Curtiss Hoffman introduced his past experience in this field and indicated that his report was circulated and in the Boards hands. Discussion revolved around some editing Hoffman's report about accepting papers for AENA and the presentation of papers. The responsibility of selecting students was decided as the Committee's and Hoffman agreed to make these changes. Additional discussion addressed the differences, or not, between papers and posters. Arthur Spiess suggested that we proceed with just the oral presentation student paper award and leave the poster portion out for now. Amanda Valko moved that we proceed as Spiess suggested, Al Smith seconded the motion and it passed unanimously.

**Finance Committee:** Wayne Clark gave an overview of his report that was circulated to the Board. He noted that the committee looked over two years of ESAF's finances and everything looked good. He noted that communications are good and that critical functions of ESAF work well. The only recommendation suggested was that an annual budget be prepared at the beginning of each year. Faye Stocum moved that we accept the report, Al Smith seconded the motion and it passed

unanimously. President John Nass thanked the chairman for his in depth report.

**Communications Committee:** Sarah Neusius, the committee Chair could not attend the meeting. President John Nass reported that because of the pandemic there was very little action in this committee. Sarah did submit a report and Faye Stocum moved that we accept the report and Al Smith seconded the motion. The motion passed unanimously.

**Old Business:**

President John Nass brought up the question of AENA reprints. Arthur Spiess reported that there were two separate issues here. First is Academic scholars wanting to post the article on their academic EDU sites. Spiess noted that this issue had been dealt with by requesting that they wait for three years before doing that to give JSTOR a chance to achieve their goals. Second is a chapter of the Ohio Archaeological Society's request to reprint some recent AENA articles for local use. Arthur Spiess reported that after consultation with other Board members he gave them permission to use the articles. However, this raises the question of other people or entities requesting permission to use AENA articles for their own purposes. Spiess further noted that all AENA authors sign a Contract agreement with ESAF granting us copyright over the article. Spiess is working on a policy for the Board to review so we will be better equipped to deal with these issues in the future. Dave Mudge suggested that since we didn't have an annual meeting for the membership to approve the actions of the Executive Board we should include something in the mailing to the general membership for their approval. It was decided that the minutes of this meeting would need to be included along with the slate of officers to be voted on, and the Treasure's report. These items need to be sent to Amanda Valko as soon as possible for distribution.

President John Nass indicated the as his term ends at the close of this meeting so do the terms of the Committee chairs. The next President, Jon Lothrop, can ask the present committee chairs to stay on or choose new chairs. President Nass further indicated that The Education Committee Chair, Curtiss Hoffman would continue to complete his work as suggested by the board.

Alan Smith made a motion to adjourn at 8:50 PM, Faye Stocum seconded the motion and it passed unanimously.

## STATE SOCIETY REPORTS

### ARCHEOLOGICAL SOCIETY OF CONNECTICUT ERNEST WIEGAND

The Archaeological Society of Connecticut has 152 memberships consisting of 117 individuals and 35 institutions. Members receive the society's annual Bulletin of the Archaeological Society of Connecticut and several newsletters announcing society activities and reporting on archaeological work being conducted throughout the state.

Due to the COVID 19 virus, the spring meeting of the society was cancelled. The continuing pandemic resulted in the cancellation of the fall meeting but members and the public were treated to a series of six weekly "virtual" presentations given by society members on recent and ongoing research projects. These ran from mid-October through mid-November and were well attended.

In addition to the annual bulletin, members also received copies of a special report: *Ten Thousand Years in a Southern New England Rockshelter: The Binette Site (6-NH-48)* by David Hall Thompson. Published as the Archaeological Society of Connecticut Monograph No. 1, Dave had nearly completed his final draft of the manuscript when he passed away in 2015. ASC members Lucianne Lavin, Nicholas Bellantoni, Zachary Singer, Cosimo Sgarlata, Sarah Sportman and Ernie Wiegand worked to put the final touches to the report, which was sent to the 2020 membership at the end of the year. This report is the first in a series of monographs on the archaeology, anthropology, ethnohistory and related topics of Southern New England and Long Island Sound.

The Brian D. Jones Grant was awarded to William Farley of Southern Connecticut State University to fund his research on the Henry Whitfield House in Guilford.

### ARCHEOLOGICAL SOCIETY OF DELAWARE FAYE STOCUM

The Archaeological Society of Delaware (ASD), is a charter member of the Eastern States Archeological Federation (ESAF). As with everyone, the ASD has adapted to the COVID-19 pandemic. The ASD, with our 3 Chapters (New Castle, Kent and Sussex) have maintained a good financial standing. Our membership stands at 121 for 2020. We decided to maintain this number from 2019. The monthly Executive Board Meetings, have become a quarterly event. At a summer Board Meeting, ASD officers-Curtis McCoy-President, John McCarthy-Treasurer, Alice Guerrant- Secretary, and Daniel Griffith- Member-at Large were re-elected. Our Website and Facebook page are active. We are including postings of Delaware and Delmarva events and items of interest. Please note, our Website includes our **Digital Library** which includes **free access to all ASD Bulletins from 1933 – 2014**. Other accomplishments we have been realized this year:

- The ASD participated in the December, 2019 Annual Delaware Valley Archaeology and History Symposium.
- A contract was let for funding research on the history of the Avery's Rest site.
- The *Bulletin of the Archaeological Society of Delaware, No. 57, New Series, 2020*, was distributed this fall. Some of the articles include: "To Drain this Country": *Historical Archaeology and the Effects of the War for Independence in the Route 301 Corridor*" by Wade Catts; "Analysis of a Delmarva Adena-Hopewell Textile Fragment Unearthed at the Frederica Site (7K-F-2) in Kent County, Delaware" by Edward Jolie and Darrin Lowery; and, "Archaeological and Historical Investigations at Wildcat Manor, Forest Landing and Hunntown (Archaeological Site 7K-C-22)" by Craig Lukezic, Robin Krawitz and Dawn Cheshaek.
- Curtis McCoy, ASD President, has undertaken a task he is calling "Digging Delaware." Curtis has interviewed Delaware archaeologists in an effort to see how they became interested in archaeology, what

are these folks doing and other topics of interest. To date, Curtis has produced 12 interviews so far. You can view these “Digging Delaware” interviews on Youtube.com.

- The ASD is now attempting to institute a new interest group. It is the “ASD Journal/Book Club.” Journal articles and/or books are selected and are provided to those who sign up. A virtual discussion is then scheduled. The first book selected is by Charles King, “*Gods of the Upper Air: How a Circle of Renegade Anthropologists Reinvented Race, Sex, and Gender in the Twentieth Century*” (2019). A discussion is scheduled in November, 2020.
- The Delaware State Historic Preservation Office sponsored a Youtube video of Raquel Flesckes (Univ. of Penn doctorate candidate). ### MAINE ARCHAEOLOGICAL SOCIETY ARTHUR ANDERSON

Though 2020 caused significant interruptions for all of us, the Maine Archaeological Society has been able to continue at least some of our traditions.

A Spring Bulletin was produced with a range of articles from both professionals and graduate students on site location, canine burials, and the Maritime Archaic tradition. A Fall Bulletin is in preparation and will be headed to the printers presently.

A Spring public meeting was not possible due to the then-emergent Covid-19 pandemic, but a Fall public meeting was held virtually via Zoom and was a joint meeting with the Association of Professional Archaeologists of New Brunswick/Association des archéologues professionnels du Nouveau-Brunswick. This had a circumstantially robust attendance of 35 and featured presentations from Dr. Gabe Hrynick of the University of New Brunswick on recent work along the Maine/New Brunswick Border and Dr. Alice Kelly of the University of Maine on the Maine Midden Minders project.

We maintain a membership of roughly 250 and hope to resume a more robust, in person public meeting schedule when safe.

### ARCHEOLOGICAL SOCIETY OF MARYLAND, INC. DON HOUSLEY, PRESIDENT

The Archeological Society of Maryland, Inc. (ASM) was established in 1964. ASM has a current membership of 244 individuals, families, and institutions. ASM has (eight) active chapters throughout the state as well as two college chapters and one high school chapter when COVID hit. The officers for the 2018-2020 were elected at the 2018 fall meeting. They are: Don Housley, President; Valerie Hall, Vice President; Lawrence Seastrum; Treasurer, Elaine Hall; Secretary; Ethan Bean, Membership Secretary; Katharine Fernstrom, Lynn Bulhack, Barbara Israel, Aaron Jarvis, Fran Kline, and Brent Chippendale for six at-large trustees. Rounding out the Board of Trustees are Dr. Matt McKnight, Editor of ASM’s journal “Maryland Archeology”, Myron Beckenstein newsletter editor, State Underwater Archaeologist, Dr. Susan Langley and State Terrestrial Archaeologist, Dr. Charles Hall. Election results for Officers for 2021-2022 are scheduled to be announced at the November 7, 2020 ASM Annual ZOOM Meeting.

The in-person **55<sup>th</sup> Annual Spring Symposium** and the in-person **29<sup>th</sup> Annual Winter Workshop** co-hosted with the Maryland Historical Trust scheduled for the end of March and April 2020, respectively were cancelled on account of COVID. Matt McKnight originally was thinking of holding it in-person **Winter Workshop** during the summer of 2020, but that idea too was replaced with recorded virtual presentations.

The **Winter Workshop** virtual program became available to the ASM membership and to the general public in August 2020. They are still available for viewing the MHT web site. The virtual program included five speakers

with opening remarks by President Don Housley,

**“Priestly Plantations: What We Know (and Want to Find Out) About the Archeology of Jesuit Sites in Maryland,”** by Laura Masur, Assistant Professor of Anthropology, the Catholic University of America; **“A bleak, barren sand beach”:** **Recent Investigations at Point Lookout Light Station** by Rob Wanner, Archeologist and GIS Technician with EAC/Archaeology, Inc.; **Cobble Reduction and Tool Production from Late Archaic through Late Woodland at the Elkridge Site** by Bob Wall, Lecturer in Anthropology, Towson University; **“The once great plantation is now but a wilderness”:** **Archeological Research at the Josiah Henson Site** by Cassandra Michaud, Senior Archeologist, Montgomery Parks (M-NCPPC) – Planning & Stewardship Division; and **Archeology at the Cloverfields Site** by Zachary Andrews, Crew Chief, Applied Archaeology and History Associates, Inc. Beginning in March 2020 due to COVID-19 Pandemic, most of the ASM planned activities were cancelled. The ASM Board of Trustee Quarterly Meetings included a March 7<sup>th</sup> in-person meeting, and three virtual ZOOM meetings on June 6, September 12<sup>th</sup>, and December 5<sup>th</sup>.

The 2020 theme for **Maryland Archeology Month** was *“Partners in Pursuit of the Past: 50 Field Sessions in Maryland Archeology”* was featured in a booklet and along with several cancelled events state-wide. The booklet for the April celebration featured thirteen articles on personal memories of the archeological field sessions. Many of the individuals involved in the organizing the field sessions are among the authors of the thirteen essays included in the booklet. The 2020 April Archeology Month theme of celebrating the 50<sup>th</sup>-Field Session in Maryland Archeology will have to wait until 2021.

#### **Annual Field Session**

For its 2020 50<sup>th</sup> **annual field session**, ASM received a non-capital grant from MHT for \$15,000. Because of Covid-19 restrictions, the field session, originally scheduled for May 2020 and then rescheduled for October 2020 was postponed until May 2021 at the Billingsley site in Prince George’s County, Maryland.

#### **ASM Annual Meeting**

The 56<sup>th</sup> **ASM virtual ZOOM Annual Meeting** is scheduled on November 7, 2020. The theme is *“Celebrating Women in Maryland Archaeology”* and is to be held virtually on ZOOM and is being hosted by the Mid-Potomac Chapter. Program presentations are **“Growing Up Female in Maryland Archaeology, or, Where the Bodies Are Buried,”** by Julia A. King, Professor of Anthropology, St. Mary’s College of Maryland; **“Women’s Work: The Josiah Henson Museum and Park,”** by Cassandra Michaud, Senior Archaeologist, Montgomery County Parks; **“Iron Mermaids, Women in Diving and Underwater Archaeology,”** by Susan Langley, Maryland’s State Underwater Archaeologist; and **“Celebrating Nine Women in Maryland Archaeology,”** by Heather Bouslog, Senior Archaeologist, Montgomery County Parks.

#### **Grants and grant proposals**

Progressing with the 2018 Biggs Ford Grant. The reports are due at the end of 2020. The grant has been extended and would be hard to extend again. The faunal analysis has been delayed because of COVID. The Biggs Ford Report will be used as the 2021 double ASM Journal issue.

In 2020, MHT received \$300,000 non-capital grants from the State Legislature. Eleven of the non-capital grant proposals are for archaeology and are due in October. However, with revenue down, there could be reductions to the fiscal 2021 budget. Grants are expected to be announced in November.

**MASSACHUSETTS ARCHAEOLOGICAL SOCIETY  
ALAN SMITH**

Since 1939 the Massachusetts Archaeological Society (MAS) and the Robbins Museum has continued as a non-profit organization with a mission to foster respect for the rich archaeological and cultural heritage of the New England region through its commitment to education, research, and historic preservation.

As with the rest of the world, Covid 19 dramatically changed the activities of the MAS in 2020 but we still accomplished some things even though we are severely impacted by the financial consequences of the pandemic. Multiple grants have been applied for to carry MAS and the Robbins Museum through the crisis. A virtual “Zoom” series with ten episodes called “Diggin' In” was established to foster public understanding of archaeology and Native American culture during the pandemic and has been a great success. So much so that Season 2 has been scheduled and is sponsored by the MAS and the Robert S. Peabody Institute of Archaeology (Sign up at [info@massarchaeology.org](mailto:info@massarchaeology.org)).

The Robbins Museum closed at the start of the pandemic, but we hope to open again in 2021. During the downtime the lighting in the Museum was upgraded and work continues with the Native community on the redesign of the “Walk Through Time Exhibit”. The Bookstore at the museum has offered more titles online and the expanded edition and the handbook edition of “A New England Typology of Native American Projectile Points” by Jeff Boudreau are selling well.

Also this past year MAS updated its Mission Statement by shortening it and updated its Organizational Objectives. The MAS objectives are as follows: a) Preserve and protect cultural and archaeological heritage; b) Provide education resources to members and community partners; c) Maintain a repository and museum of archaeological and ethnographic collections; d) Create and disseminate publications; e) Establish affiliated branches (Chapters); f) Affiliate with other organizations. Work still continues on upgrading the MAS website and updating the bylaws with both near completion.

MAS has a new Bulletin Editor and the MAS 2019 Spring and Fall issues were combined into a double issue with articles titled “How Bill Ritchie Got to Martha's Vineyard and the Crew Members Who Joined Him” by James B. Richardson III; “An Updated History of the Hornblower II Site, Martha's Vineyard” by Jessica E. Watson; “Transitional Archaic and Woodland Occupation at the Frisby-Butler Site, Martha's Vineyard” Jessica E. Watson; and the “McDermott Site Martha's Vineyard”.

The Spring and Fall 2020 Bulletin articles were “Remembrance: Frederica Rockefeller Dimmick (1934 – 2019)” by Tonya Baroody Largy, Ian W. Brown, John Rempelakis, William A. Griswold, William P. Burke, and Philip Graham; “New Directions on Old Roads: A History of Transportation Archaeology in Massachusetts” by John Rempelakis; Discovery of a Small, Isolated, High-Density Lithic Workshop in Interior Massachusetts by Alan E. Strauss; Post-Contact Upland Sites near Lake Chaubunagungamaug” by Martin G. Dudek; and “Native Agricultural Villages in Essex County: Archaeological and Ethnohistorical Evidence” by Mary Ellen Lepionka.

The 2020 Spring Meeting to be held on April 18 was canceled due to the Covid 19 pandemic and an abbreviated Fall Annual Meeting was held outdoors at the Robbins Museum on November 21, 2020 without the normal presentations due to the pandemic.

The membership in the Society stands at 288 paid members.

**ASSOCIATION OF PROFESSIONAL ARCHAEOLOGISTS OF NEW BRUNSWICK  
GABE HRYNICK**

The Association of Professional Archaeologists of New Brunswick is a new member of ESAF. We hope through our membership to better integrate the archaeology of New Brunswick with the rest of the eastern states and

provinces. One of our goals in joining ESAF is to contribute to bridging what David Sanger once called an “intellectual fault line” separating the archaeology of eastern Canada from the United States.

We appreciate this opportunity to introduce our organization. We were founded in 2013 to represent the profession of archaeology in New Brunswick, promote the protection of archaeological resources, and to encourage the dissemination of information about New Brunswick’s archaeology in public and professional fora. A considerable amount of our work focuses on advocating for our profession to the provincial government and for improved working conditions to archaeologists. (Canada lacks the robust federal heritage legislation and history of CRM that the United States has, making this kind of provincial level advocacy crucial.) However, although we were founded as a professional organization, New Brunswick has no active archaeological society. We therefore assume many of the traditional roles of an archaeological society, including public education and outreach to avocational archaeologists. To this end, the APANB has devoted a substantial amount of its COVID-time energy to expanding our lecture series in a virtual format. Since the fall, we have hosted or co-hosted lectures on a range of topics by a variety of archaeologists, many of whom will be familiar to the ESAF audience: Ken Holyoke, Sue Blair, Kevin Leonard, Adrian Burke, Trevor Lamb, Alice Kelley, Gabe Hrynicky, and Michael Chazan. We invite you to visit our website ([apanb.ca](http://apanb.ca)) for information about upcoming presentations.

We are particularly pleased with our collaborations with our neighbour society, the Maine Archaeological Society. While the border is currently closed, we look forward to a time when our societies may explore more in-person collaborations here in the Far Northeast.

In addition, our organization strives to be an articulation between New Brunswick archaeology and that in the rest of North America. We have affiliations with other organizations, such as the Register of Professional Archaeologists and the Canadian Archaeological Association, that provide our members with discounted membership or a voice on their boards. We also work to provide continuing education for our members, although some of the hands-on aspects of this have been delayed by COVID-19. Student mentoring is a crucial part of our work.

We look forward to further developing our society and contributing to ESAF, and are pleased to formalize a relationship many of our members have long had with it.

**ARCHAEOLOGICAL SOCIETY OF NEW JERSEY  
DAVID C. MUDGE**

As with most other organizations, the Archaeological Society of New Jersey (ASNJ) has had to adjust and adapt to survive in this new pandemic environment. Starting in March, the ASNJ reluctantly agreed to suspend all in person meetings for the duration of the emergency. The ASNJ also quickly got on the ZOOM bandwagon and has used that program to conduct its business and explore new methods of outreach and education.

Through October, 2020, the ASNJ has continued to work hard to fulfill and extend its stated missions of advocacy and education in the Garden state. Our membership stands at 266, which is up almost 10% from last year. Our bank accounts currently exceed \$51,000, which helps us to pursue our varied activities.

We continue to fund two research grants which help students and other scholars pursue meaningful research in our state.

We also traditionally fund student support to attend the Middle Atlantic Archaeological Conference. In addition, several of our members also support this activity. Unfortunately, due to the cancellation of the 2020 MAAC meeting, we could not actually fund any students. However, we left the funds with MAAC to support student funding for the next meeting.

In the last few years, mirroring many other organizations, the ASNJ has expanded its web presence via facebook, twitter, etc. and radically redesigned our own webpage. Overall, our web traffic has increased over 33% from the same period last year.

With the pandemic, the ASNJ has been unable to organize or aid in any public or individual archaeological projects. However, we have instituted a new series of public ZOOM presentations on archaeological efforts. These are scheduled to occur about every two weeks, and are generally a short presentation followed by a discussion period. We have held eight so far. After each presentation, the entire event is archived to our YouTube channel, where it continues to attract viewers.

We are currently in discussion to begin a series on general archaeological topics, to be given in short 5 to 10 minute lengths, to be available for teachers to use in classroom situations.

The ASNJ continues to publish 4 newsletters per year, plus a substantial Annual Bulletin that is usually about 150 pages, making it one of the larger publications in our region.

Due to the cumulative efforts of many of our members, the ASNJ has managed not just to survive this crisis, but to expand its mission and thrive.

**OHIO ARCHAEOLOGICAL COUNCIL  
MARTHA POTTER OTTO**

Like so many other organizations, this year's activities for the OAC were greatly affected by the COVID-19 pandemic. Both our spring and fall meetings were held virtually with a variety of presentations focused on members' current research. The spring 2021 meetings, scheduled for May 7, will also be virtual; we will be hosting a poster session with breakout "rooms" on WebEx for people to talk about different posters.

In 2020, the OAC put an emphasis on publishing in various forms. In March, the University of Akron published *Encountering Hopewell in the Twenty-first Century, Ohio and Beyond: Volume Two; Settlements, Foodways, and Interaction*. This publication follows *Encountering Hopewell in the Twenty-first Century, Ohio and Beyond Volume One: Monuments and Ceremony* that came out in May 2019. Both are edited by Brian Redmond, Bret Ruby, and Jarrod Burks. The publications document presentations given in the 2016 Hopewell Conference organized by the OAC in Chillicothe, Ohio.

Volume 7 of the peer-reviewed, online Journal of Ohio Archaeology presents a Special Issue on Serpent Mound Research edited by Jarrod Burks. This publication includes three papers reporting on recent research into the iconography of the serpent effigy, activity areas on the plateau surrounding the effigy, and the effects of New Deal projects at the site. This publication is available on the OAC's website, [www.ohioarchaeology.org](http://www.ohioarchaeology.org).

Also on the website is Current Research in Ohio Archaeology that compiles short articles and abstracts, often of papers presented at OAC meetings, covering a wide range of topics. The most recent entry is Climate Change and Deer Consumption of Maize at the Turpin Site, ca. A.D. 700-1300 by Robert A. Cook and Aaron R. Comstock.

At the beginning of 2020, the OAC had expected to spend time organizing the 2021 ESAF Annual Meeting to be held at Newark, Ohio. However, the COVID-19 pandemic quickly intervened. In the fall, OAC President Kevin Nolan and Education Committee Chair Bob Genheimer met electronically with the ESAF Executive Board and decided that conditions would likely not be conducive to in-person meetings in the fall of 2021. The conclusion

of this meeting was that the 2021 ESAF meeting should be virtual, and the Newark, Ohio meeting should be postponed until 2022. The nomination of a number of major Hopewell earthworks sites to the World Heritage List will still be a major theme.

## ARCHEOLOGICAL SOCIETY OF VIRGINIA MICHAEL B. BARBER

The Archeological Society of Virginia is pleased to report a **membership of 718**, in addition to 54 **institutional members**. Currently, there are **16 ASV chapters** around the state. The two newest chapters are the Maritime Heritage Chapter (our first thematic chapter) and the Historic Triangle Chapter centered in Williamsburg. The Maritime Heritage Chapter has launched a logboat registry which has been extremely successful in recording these rare and disappearing resources. The HT Chapter hosted both the 2019 and 2020 annual meetings.

The **2020 Annual Meeting** was held on October 14 and 21 and, due to the Covid 19 virus, was virtual. Registration was free with 112 joining the meeting. During the two meeting, with Stephanie Jacobe as moderator, four sessions were held on Historic Archaeology, Maritime Archaeology, and Native American Archaeology, and a poster session. Each was two hours long with discussion. An average of 40 people zoomed in for each presentations. Papers and Posters will remain on the ASV website until the end of the year. Although the meeting was a complete success, we hope not to do it again next year.

The **Archeological Technician Certification Program** is healthy under the leadership of Co-Chairs Carole Nash and Bruce Baker. Approximately 30% of the ASV's membership has either graduated from or is enrolled in the Cert Program. Currently 115 ASV members are enrolled. The obvious challenge lies with the inability to meet in groups for lectures, lab work, and field work. Many limitations are being overcome with zoom meetings but some requirements cannot be done virtually and innovative solutions are being developed. In addition, a 'Citizen Scientist Program' is being developed for the graduates interested in pursuing research. In cooperation with DHR and CoVA, *The Archaeology of Virginia's First Peoples* has been published and available through Amazon. Edited by Bernard Means and Elizabeth Moore, the volume has eleven chapters beginning with underlying environmental data and tracing cultural development from Paleoindian to Contact. In addition, Martha McCartney's book, "*Twin Paths to Freedom: Two Free Black Communities in James City County, Virginia*" has gone through peer review and the final editing process.

ASV continues work on the **Strategic Plan** which has been slowed by Covid 19. The effort is led by John Broadwater and will eventually outline goals for next 5 years along with action items. The four goals of Education and Outreach, Research, Preservation, and Collaboration form the body of the plan. One of the major considerations is how Kittiewan Plantation, ASV's physical center, will be incorporated into the plan. Work continues and a deadline of January 1, 2021 is set for completion.

**Election of Officers** was completed prior to the annual meeting. The slate is made up of President – Mike Barber, Vice President – Patrick O'Neill, Secretary – Stephanie Jacobe, Treasurer – Lisa Jordan, and Assistant Treasurer – Carl Fischer.

With COVA, the ASV is pleased to support the **Virginia Archaeology Charitable Trust (VACT)**, a crowd-sourced funding mechanism for archaeological site excavation or collections-based research. Projects will be vetted by an advisory board once VACT's non-profit status is confirmed.

Thane Harpole, ASV *Quarterly Bulletin* editor, is on the lookout for articles and glad to talk with you about publication. The QB is indexed by EBSCO. We will also have some new publications in the coming year and are very pleased to have partnered with COVA on *The Historical Archaeology of Virginia*. We have established a 'print-on-demand' account w/ Amazon for our older publications and will selectively publish in hard copy our

newer volumes.

Finally, we would offer condolences to the family of Jack Hranicky and recognize his lifelong support of Virginia archaeology. Jack represented the ASV at ESAF for its entire existence and he will be missed.
